- _ Instability of oil and construction materials prices.

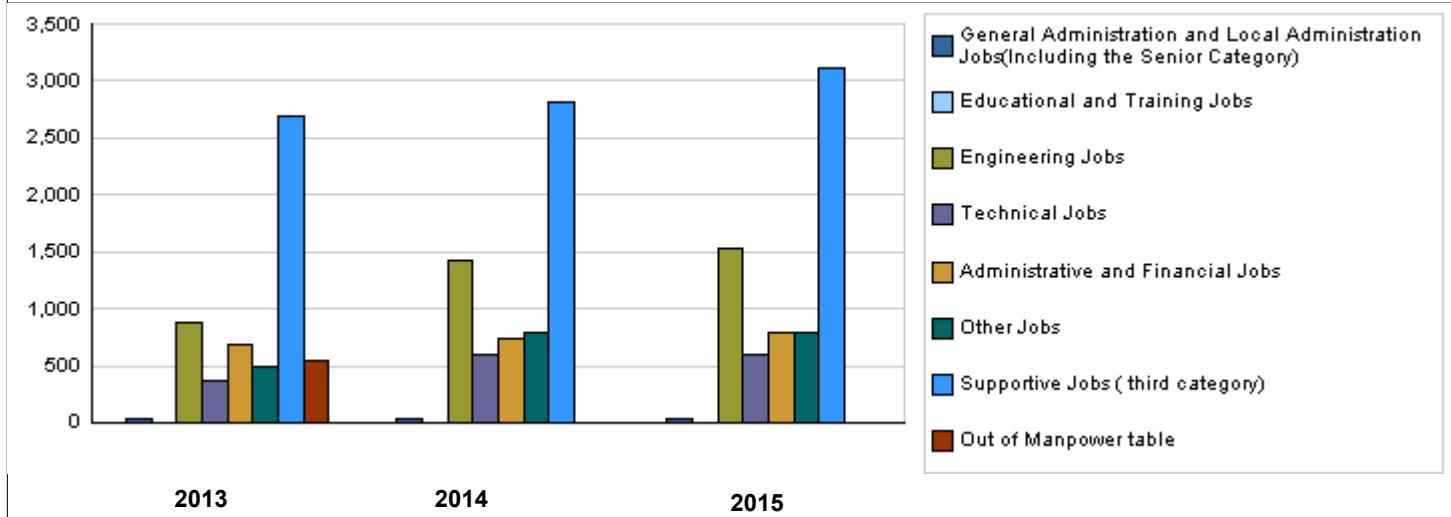

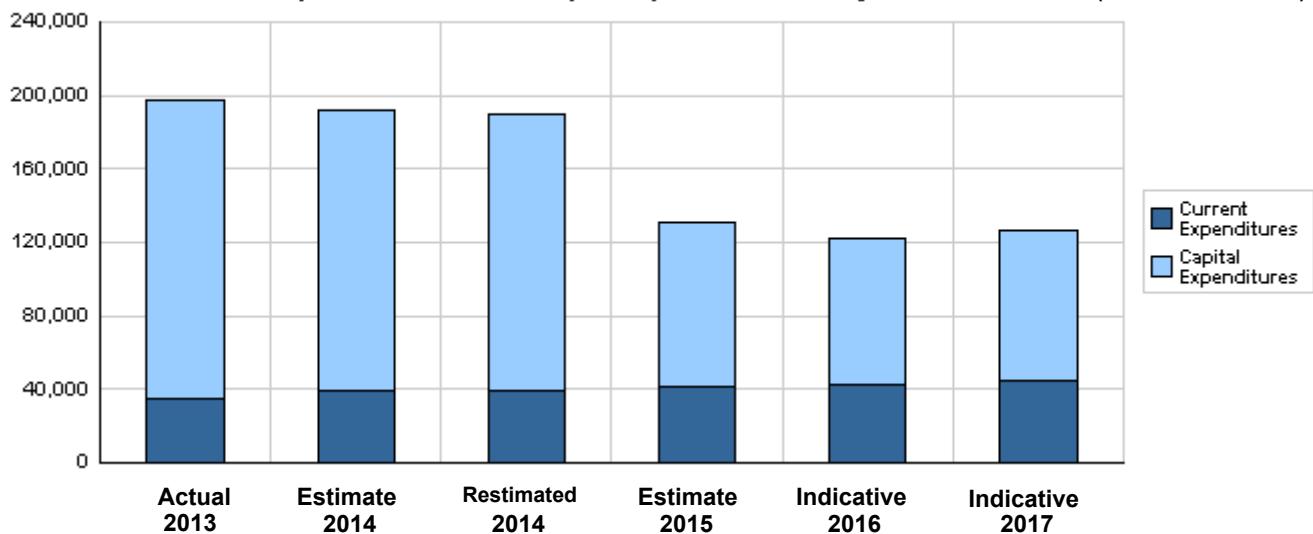

Graph of the current and capital expenditures for the years 2013 - 2017 (Thousands of JDs)



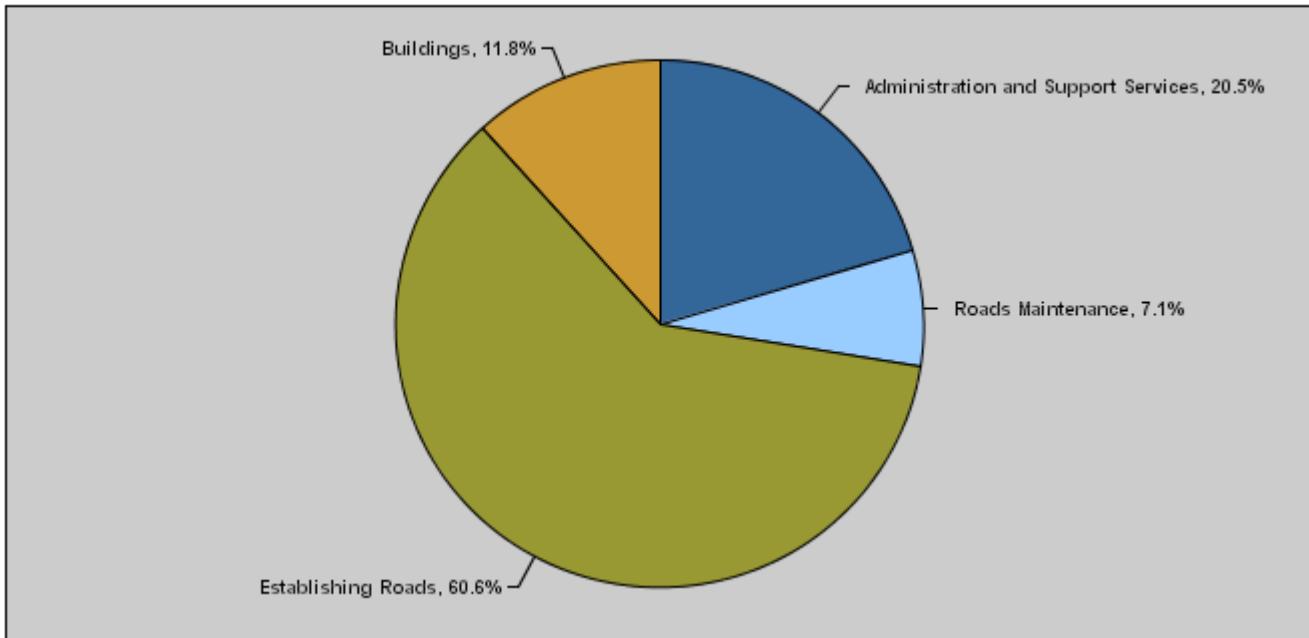
