Agricultural Development and Natural Wealth Sector

Key differences between the estimated appropriations for 2024 and the re-estimation for 2023 of the sector :

Current expenditure:

- The current expenditure allocations increased by approximately (163) million JDs, concentrated on:
- The appropriations of employees compensation items increased by about (25) million JDs due to the natural increase of salaries in addition to the cost of vacancies and new jobs to be recruited in 2024.
- Increased allocations for operational expenditures by approximately (51) million JDs. This increase was concentrated in the Water Authority's water prices by (42) million JDs.
- Interest allocations increased by approximately by (84) million, concentrated on the increase in the domestic loan interest item of the National Electricity Company.
- Other expenditure allocations increased by approximately (3) million JDs, concentrated on higher contribution and service contracts in Miyahuna items.

Capital expenditure:

- A) Allocation of capital projects to the ministries increased by approximately (26.5) million JDs as follows:
- Allocations for economic modernization projects increased by approximately (5.5) million JDs and were concentrated in the budgets of the Ministry of Water and Irrigation, the Ministry of Energy and Mineral Resources and the Ministry of Agriculture.
- Allocating financial appropriations for new projects of approximately (6) million JDs, concentrated in the budgets of the Ministry of Agriculture and the Ministry of Water and Irrigation.
- The increase in the allocations of decentralization projects by approximately (2.8) million JDs was concentrated in the budget of the Ministry of Water and Irrigation.
- Increased allocations for ongoing and committed projects by approximately (12) million JDs.
- b) Appropriations of the capital projects of government units increased by approximately (42.5) million JDs as follows:
- Allocation of funds for new projects of approximately (10) million JDs, concentrated in the Water Authority and the Jordan Water Company (Miyahuna) budgets.
- The allocation of ongoing and committed projects increased about (32.5) million JDs.
