Financial Administration and Planning Sector

Key differences between the estimated appropriations for 2025 and the re-estimation for 2024 of the sector :

Current expenditure:

- The value of the increase for the financial management and planning sector for 2025 compared to the re-estimated 2024 amounted approximately (206.2) million JDs, as a result of which:
- Compensations of employees increased by (6) million JDs, this is to cover the cost of the natural increase in the salaries and wages group and to allocate appropriations for the cost of vacancies and new jobs for 2025.
- Use of goods and salaries group appropriations decreased by (6.7) million JDs, this increase concentrated in the Ministry of Finance.
- Debt interest allocations (internal and external) increased in the amount of (120) million JDs to cover interest on internal loans and external loans interests.
- Increased pension and compensation allowances in the amount of (64.6) million JDs to cover the cost of salaries of civilian and military retirees and the early retirement salaries of the military services subject to social security.
- Other expenditure appropriations increased by (2.4) million JDs due to the increase of tax refunds appropriations (sales and income).
- Increase in public expenditure allocations in the amount of (40.1) million JDs, as this increase was concentrated under medical exemptions.
- The appropriations of subsidies for supporting goods decreased by (13.7) million JDs.
- Emergency expenditure appropriations decreased by (10) million JDs.

Capital expenditure :

- Capital expenditures for the financial management and planning sector for 2025 increased with a re-estimated of the year 2024 of approximately at (35.9) million JDs, notably:
- Increase in the allocation of a number of projects by (2) million JDs, including: Implementation and supervision of Amman New Customs Center/ Al-Madounah in the amount of (685) thousand JDs, the project of tracking and managing electronic transit trucks in the amount of (350) thousand JDs, the project of the television surveillance system of customs patrol in the amount of (250) thousand JDs, the project of supporting services and infrastructure in the amount of (265) thousand JDs, and the project of the prior approvals and licenses system in the amount of (200) thousand JDs.
- Increase in the allocation of the project to strengthen institutional capacities by (615) thousand JDs within the budget of the Ministry of Planning.
- Increase in the allocation of the National Accounts Statistics Compilation System project within the budget of the Department of Public Statistics by (100) thousand JDs.
- Increase in the allocation for the purchase and equipping of a building for the Department of Government Procurement by (150) thousand JDs within the budget of the Department of Government Procurement.
- Increase in the appropriations of the Department's Financial Regulations/Tax Accounting Project for linking with the departments and commissioners in the amount of (400) thousand JDs within the budget of Income Tax and Sales Department.
- Increase in the financial allocation required to cover the cost of taxes and fees for grant-funded projects by (19) million JDs within the budget of the Ministry of Finance.
- Allocations were made for the Amman Service Development Project in the amount of (10) million JDs within the budget of the Ministry of Finance.
- Appropriations have been made for the Railway Property Project in the amount of (3) million JDs.
